Chairman's and Treasurer's Report—2014



The management structure of the VA has served the village well for over four decades, but relies upon people to make it work!

I take the unusual step of writing a combined Chairman's and Treasurer's report, as I have been fulfilling both roles since the last AGM. Sadly, this is a reflection on the lack of people putting themselves forward for service to the community of New Ash Green. Instead of a Council of Management with a full complement of nine, there have only been six members for the last year.

The management structure of the Village Association (VA) has served the village well for over four decades, but relies upon people to make it work! The VA changed its constitution some years ago to allow virtually everyone to have the opportunity to participate in the management of the village, to no avail. The village was founded on the basis of local democracy and accountability. Residents have the opportunity to shape their environment to suit local wishes, and not controlled by central government and local authorities, nor subject to financial *diktat* from outside.

Buying a property in New Ash Green is effectively buying a share in a large country estate, the setting for your house. Your VA contribution (and Resident Society (RS) subscription) support the maintenance or improvement of the village. Your contributions are used solely for service delivery; no member of the VA receives any remuneration.

At a time when family incomes are failing to keep up with generally increasing costs, members of Council of Management (COM) are acutely aware that any increase in contributions is

unwelcome. For a number of years, the contribution rate was frozen, with a modest increase last year. As for each household, the VA is faced with increased costs for energy, particularly electricity (street lighting and our premises) and fuel costs (greenland machinery and premises heating), which is unavoidable. COM has the invidious task of balancing residents' justifiable expectation of the village being maintained to the highest standards, yet maintaining contributions at the lowest level. A very modest increase is proposed for 2015 (3.03%). For the future, there will be further exploration of minimising the income requirement, by deferring what we can whilst seeking to maintain high standards. There is a "trade off", deferring repaints, for example, can lead to our infrastructure becoming a bit shabbier, and with the possibility of increased decay, through reduced protection.

The VA provides a number of facilities for active recreation and leisure, such as children's play areas and the sportsfield. The VA owns the sports pavilion, and supports the cost of running the changing facilities and sportsfield maintenance, whilst the social side of the building is managed by its subsidiary, New Ash Green Sports Pavilion Ltd (NAGSPL), which is charged with operating the social side without burden upon residents. It is *your* building and I would encourage residents to use it to fullest advantage.

The Shopping Centre is not in the control of the VA, and continues to blight the village, though there have been limited improvements

recently. The VA and local District Councillors, via Sevenoaks District Council, are doing everything possible to achieve a worthwhile regeneration of the Shopping Centre by pressuring the landlords. We seek an outcome which will benefit the village and its residents, enhancing amenity and adding to the value of our homes. It is proving to be a long battle!

I conclude by saying that I believe the VA continues to be in a sound financial position. Following transfer of the responsibility for sewer maintenance to Thames Water, reserves have been run down a little as it is not necessary to provide for sewer maintenance and repair. Reserves are maintained, however, to cushion the impact of large items of expenditure, such as tractor purchase.

New Ash Green remains a great place to live!!

Statutory Off-Road Notifications (SORNs)

All common land in New Ash Green is known as amenity land and is owned by the Village Association (VA). Areas within neighbourhoods (such as car parking bays/driveways etc.) are also amenity areas and are owned by the VA but are the responsibility of the relevant Residents Society with the exception of Redhill Wood and The Mead (most of which have private drive-ways/areas).

As stated in our bylaw:-

No person shall cause or permit any motor vehicle owned or kept by him or in his charge to enter or remain on any part of the amenity land unless it complies in all respects with all legislation for the time being in force relating to the use of motor vehicles on the public highway, including in particular (but not

exclusively) the requirements that (i) there is in force in relation to the vehicle a policy of insurance satisfying the requirements of Section 143 of the Road Traffic Act 1988; (ii) the vehicle complies with all regulations made pursuant to section 41 of the Road Traffic Act 1988 relating to the construction and use of vehicles and equipment; (iii) there is fixed to and exhibited on the vehicle a current vehicle excise licence as prescribed by section 1 of the Vehicles (Excise) Act 1971.

- **The VA cannot consent to the keeping of a vehicle with a SORN on amenity land.**
- **SORNs should not be applied to your vehicle unless you are keeping it in a private garage at all time (with the exception**

of Redhill Wood or The Mead).

- **Vehicles should comply with all current legislation for use on the road, so they should be taxed, insured and have an MOT (as necessary).**

The VA/Residents Society has the right to have a vehicle removed from amenity land if it does not comply with the above.

The Government has now introduced a new website whereby you can check whether vehicles are taxed and have a current MOT this can be found at www.gov.uk/check-vehicle-tax, there is also an online link to report vehicles that are untaxed. Please note that since 1st October 2014 there is no longer a requirement to display a tax disc on a vehicle.

Your Neighbourhood Plan

Consultation meetings were held in the summer to ask people for their views on the planning policies that have been produced for our parish Neighbourhood Plan. Here is a summary of what you said. [If you want to comment, send your views to the Village Association office.](#)

In New Ash Green Shopping Centre key shops must be retained, including the pharmacy, bank, post office newsagent and supermarket; adequate car parking for all uses is essential. New housing in the Centre will only be allowed as a part of a larger project and people want smaller houses or apartments, tied into the New Ash Green management structure. The Plan will support retaining employment sites and adding more, so people can work near their homes. If a suitable care home site becomes available this will be supported.

There is strong support for protecting school sports fields, and other sports

facilities, from development for any other use and a new parish burial ground will be supported, on a suitable site.

The Village Association's enforcement of design guidelines is supported although some felt that standards have fallen and there needs to be more interaction with residents for the good of New Ash Green. Some people would support a conservation area for the Eric Lyons designed parts of New Ash Green, but the majority view is that the Village Association's controls are sufficient. Open space must be protected to preserve the character of New Ash Green but some see a need to extend residential car parking spaces whilst preserving the integrity of the landscaping. The Plan needs to set out how this balance can be maintained.

Some other issues were raised by residents which would not be accepted as part of a Neighbourhood Plan but they will provide evidence

to back up lobbying for improvements. They include 20mph speed limits in residential areas, road improvements, footpath maintenance, telephone and broadband, street lighting and cheaper, reliable and more frequent bus services to more places.

Three top tips to keep your loved ones safe this winter

With winter well and truly here, Kent firefighters are asking local people to take extra care and to think about how they can help elderly relatives and neighbours. Just three breaths of fire smoke can be fatal and babies and older people are most at risk.

If you know someone who is using an old portable heater please check that it is stable

and safe. Our free home safety check can make all the difference to someone staying safe and secure in their own home. Call us on 0800 923 7000.

Enjoy your open fire or log burner safely by making sure you follow a few simple safety tips. Get your chimney swept at least once a year, use a fire guard and inspect your chimney breast, particularly in the roof space as you'd be surprised at how many chimney fires we attend.

Finally if you or your children are out for a walk please be aware of the real dangers around rivers and ponds. We also often have to rescue walkers who have got stuck in mud while out walking - often when they have gone to rescue pets. Ground around water may look safe, but you can quickly become stuck in mud and find yourself in a very dangerous position. So please stay on paths and solid ground and always carry a phone so you can call for help.

Wassail with the Woodlands Group

New Ash Green Woodlands Group invites you to their 10th annual Wassail at 4.00 pm on January 3rd 2015 at New Ash Green Village Hall (DA3 8HH). Bring torches or lanterns for the short flaming torch-lit procession to the village orchard, and something to make noise with!

The ancient Wassail custom involved local farm-workers visiting their orchards after dark each January for a mid-winter party. The best tree had cider poured over its roots and pieces of toast soaked in cider placed in the branches and impaled on twigs to attract beneficial wildlife. Wassail songs were sung to encourage a good crop and the tree would be toasted loudly and merrily.

Horns would be blown to awaken the tree from its winter slumber.

The volunteers of New Ash Green Woodlands Group have worked hard since 2004 to regenerate the orchard, which sits in the centre of the village. So our Wassail is partly about toasting the good health of the trees and partly to celebrate the revival of our brilliant 100 year-old community orchard. Last year more than 100 people joined us. The whole event is a lot

of fun and the flaming torches help create a fantastic atmosphere. Why not come and help us keep this new and ancient custom very much alive?

NAG Cinema Needs New Core Group

New Ash Green Film Society has reluctantly decided to close down unless younger volunteers can be found to create a new core group.

The Society which was originally founded in 1969 ran till 1985 and was re-started about five years ago running till July 2014.

In that time we have screened a very wide diversity of film genres from the early days of film, to films currently on general release at main cinema chains.

The only other cinema offering such a wide range is British Film Institute on the South Bank in London.

As well as showing films, the Society has functioned as a social meeting space for old friends to keep in contact and for new friendships to be formed and the social aspect

of the Society was always a principal reason for its existence.

The present core group has very much enjoyed the film evenings and the contact with other local residents, but the time has come to hand over to a much younger membership if fresh ideas are to be generated and the Society is to be sustainable into the future.

The Society already has all the equipment, five metre screen, digital projection and surround sound audio, necessary to function as a cinema so, unlike when we started, there are no up-front costs to be met.

A new core group would be given a totally free hand to operate the Society as they wish. Members of the exist-

ing group would be on hand to help if needed but all final decisions would be by the new core group.

The Society is currently run by first generation NAG residents but it is now time for second generation, local residents now in their 30s/40s/50s, to take over and provide a sustainable future for NAG's Cinema.


